- **F.E.R.C. No. 2.17.0** contains local, uncommitted rates which have been increased. The tariff is filed under authority of 18 C.F.R. 342.4(b), *market-based*, pursuant to the Commission's Order on Application for Market Power Determination, Saddlehorn Pipeline Company, L.P., Docket No. OR22-2-000, issued October 6, 2022.
- **F.E.R.C. No. 4.11.0** contains both committed and uncommitted local rates which have been increased. Uncommitted local rates are increased under authority of 18 C.F.R. 342.4(b), *market-based*, pursuant to the Commission's Order on Application for Market Power Determination, Saddlehorn Pipeline Company, L.P., Docket No. OR22-2-000, issued October 6, 2022. Increased committed rates are filed under authority of 18 C.F.R. 342.4(c), *settlement rates*.
- **F.E.R.C. No. 10.6.0** contains increased contract rates filed as settlement rates pursuant to Commission Order on Petition for Declaratory Order under OR 19-31-000, issued November 21, 2019.
- **F.E.R.C.** No. 7.8.0, F.E.R.C. No. 8.8.0, F.E.R.C. No. 9.4.0, and F.E.R.C. No. 11.6.0 are joint tariffs. F.E.R.C. No. 7.8.0 provides service from Ft. Laramie, WY to Cushing, OK. F.E.R.C. No. 8.8.0 provides service from Cheyenne, WY to Cushing, OK. F.E.R.C. No. 9.4.0 provides service from Rose Rock Terminal Junction in Platteville, CO, to Cushing, OK. F.E.R.C. No. 11.6.0 provides service from Matador CDP in Adams County, CO to Cushing, OK. All joint rates have been increased and remain at or below the sum of the local rates. A schedule showing the sum of the local rates for these joint movements is attached.
