Re: Longhorn Pipeline – Crane to El Paso LMC #31 and #39 Request

Dear Mr. Ochs.

Magellan Pipeline Company, L.P. (Magellan) desires to make modifications and enhancements to the Longhorn Pipeline refined products system from Crane, Texas to El Paso, Texas. These improvements will provide operational flexibility to support additional refined products to the El Paso market in response to increased consumer demand.

Per the Longhorn Mitigation Plan (LMP) Commitment Item 39, and consistent with prior modifications to throughput capacity on this system, Magellan hereby proposes to modify the LMP System Description to show a new approved flowrate on the refined products Crane to El Paso pipeline and El Paso Lateral pipeline systems (See Attachment #1 for details). No changes are proposed for the Crane to East Houston crude oil pipeline.

Per the Longhorn Mitigation Plan (LMP) Commitment Item 31, Magellan respectfully requests PHMSA's review of the hydraulic surge pressure analysis and approval of proposed mitigation measures detailed in the attachments included herewith.

As required in the Longhorn Mitigation Plan, the proposed modification in the form of this letter has been made available to the public by posting on the Magellan website, and copies of this letter have been sent to the General Manager of the Lower Colorado River Authority (LCRA), and to the Mayors of Houston, Austin, and El Paso at the addresses shown below.
