The accompanying Magellan Pipeline Company, L.P. ("MPL") tariff, issued on September 28, 2023, to be effective on October 1, 2023, is sent to you for filing in compliance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission ("Commission"). This tariff is issued by Jake Nolte, Supervisor, Pipeline Tariffs of MPL, and are concurred in by all carriers named therein as participants under the concurrences or authorizations now on file with MPL.

F.E.R.C. No.170.41.0 cancels F.E.R.C. No.170.40.0 (IS23-400-000)

F.E.R.C. No. 170.41.0 is a volume incentive tariff. F.E.R.C. No. 170.41.0 establishes a new quarterly volume incentive program and rates to Chippewa Falls, MN.

Pursuant to 18 CFR 341.14 (Special Permission), MPL requests that it be granted a waiver under Section 6(3) of the Interstate Commerce Act to file this tariff on two (2) day's notice to allow shippers immediate access to the incentive rates contained in the accompanying tariff.
