The accompanying Magellan Pipeline Company, L.P. ("MPL") tariff, issued on December 16, 2015, to be effective on January 16, 2016, is sent to you for filing in compliance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission. Said tariff is issued by Tina R. Granger, Pipeline Tariffs of MPL.

F.E.R.C. No. 171.16.0 canceling F.E.R.C. No. 171.15.0, IS15-387-000

F.E.R.C. No. 171.16.0 is filed under authority of 18 CFR 342.4 (b) pursuant to the Commission's Order on Application for Market Power Determination, Longhorn Partners Pipeline, L.P., Docket No. OR98-12-000, issued June 30, 1998. This tariff is an incentive tariff which has increased the joint incentive rates from Port Arthur, TX to Santa Teresa (UP Fuel Depot), NM, in Item 400 by 1.0 cent per barrel. These increases synchronize with the Explorer Pipeline's F.E.R.C. No. 100.49.0, general tariff increase filed December 1, 2015 to be effective January 1, 2016, (Docket IS16-106-000) and filed under authority of 18 CFR 342.4 (b) Market-Based pursuant to the Commission's Order on Application for Market Power Determination, Explorer Pipeline Company, Docket No. OR99-1-000, Issued June 30, 1999. No other rates in this tariff have been changed and all rates are below the base rates.
