The accompanying Magellan Pipeline Company, L.P. ("MPL") tariffs, issued on December 1, 2017, to be effective on January 1, 2018, are sent to you for filing in compliance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission. Said tariffs are issued by Tina R. Granger, Pipeline Tariffs of MPL.

**F.E.R.C. No. 166.16.0 canceling F.E.R.C. No. 166.15.0, IS17-289-000
F.E.R.C. No. 171.22.0 canceling F.E.R.C. No. 171.21.0, IS18-58-000**

F.E.R.C. Nos. 166.16.0 and 171.22.0 are filed under authority of 18 CFR 342.4 (b) pursuant to the Commission's finding of lack of market power in Opinion No. 391 (68 FERC 61,136) and in Opinion No. 391-A (71 FERC 61,291) and 18 CFR 342.4 (b) pursuant to the Commission's Order on Application for Market Power Determination, Longhorn Partners Pipeline, L.P., Docket No. OR09-9-000, issued June 30, 1998 and 18 CFR 342.4 (b) pursuant to the Commission's Order on Application for Market Power Determination, Chevron Pipe Line Company, Docket No. OR00-6-000, issued April 25, 2001. F.E.R.C. No. 166.16.0 increases the joint rates to Carthage, MO; Mount Vernon, MO, Rogers, AR, and Springfield, MO by 4.7 cents per barrel from all origins and rates to St. Charles, MO by 5.0 cents per barrel from all origins. Additionally, rates to Albuquerque Station, NM, Belen Station, NM, El Paso (SFPP-Kinder Morgan Pipe Line), TX, El Paso (PMI-Frontera Juarez Pipeline), TX and Santa Teresa (UP Fuel Depot), NM have been increased by 2.2 cents per barrel from Port Arthur, TX. Incentive rates from Pt. Arthur, TX to Santa Teresa (UP Fuel Depot), NM in F.E.R.C. No. 171.22.0, Item 400 are also increased by 2.2 cents per barrel. Incentive rates are below the base joint rates. These increases synchronize with the Explorer Pipeline's F.E.R.C. No. 100.70.0, general tariff increase filed December 1, 2017 to be effective January 1, 2018, (Docket IS18-68-000) and filed under authority of 18 CFR 342.4 (b) Market-Based pursuant to the Commission's Order on Application for Market Power Determination, Explorer Pipeline Company, Docket No. OR99-1-000, Issued June 30, 1999.
